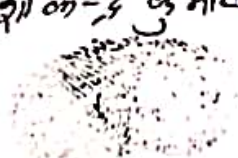
a) AIMS & OBJECTIVE

- 1- To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institution of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- 2- The establish, develop, maintain and grant aid in cash or in kind to hospitals, medical schools, medical college, nursing institutions, dispensaries, maternity homes, child welfare centers and/or such other similar charitable institutions in India for the benefit and use of the general public.
- 3- To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, color, race, creed or sex.
- 4- To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music drama and fine arts, for the preservation of historical monuments and for the research and other

institutions, in India, having similar objects for the benefit of the public in general.

5- To grant aid or render assistance to other public charitable trusts of institutions.

b) BOARD OF TRUSTEES:-

A- The management and control of the trust and the trust properties shall vest in the Board of Trustees which shall comprise of not less than three and not more than seven trustees including the chairman and the Managing Trustees. Shokendera Kumar shall be the Chairman, Subodh Kumar shall be the Vice Chairman and Smt. Vidya Devi shall be the managing trustee.

All the declarants herein will be the first trustee. The Board shall determine the strength of the Board from time to time.

B- The tenure of the first Board of trustees shall be for a period of five years and provisions for retirement of such Board of Trustees shall be applicable in respect of them only after first five years.


C- All other trustees to be appointed subsequently will hold office of a period of three years after which one-third of them shall retire by rotation on the basis of their seniority.


D- There shall be Board of Trustees constituted by not more than seven members.

c) APPOINTMENT OF NEW TRUSTEES:-

(A) After the completion of the tenure of office of the trustees, they shall retire but shall be eligible for re-appointment.


(B) In case of vacancy/ vacancies, new trustees shall be appointed from among the representative of voluntary organization, funding agencies and independent experts in the field of development, finance, legal and other related matters.

(g) POWER TO PURCHASE, HIRE OR TAKE ON LEASE MOVEABLE OR INNMOVEBALE PROPERTIES

The Board of Trustees shall be entitled to purchase or hire or to take on lease a property or properties for the purpose out the objects of the trust hereby created.

(h) POWER TO BORROW

The Trustees may form time to time, at their discretion for the furtherance and carrying out the objects of the trust of THESE PRESNETS, borrow such sum as may be determined by the board of trustees from time to time in form and manner thereupon. The trustees shall, at their discretion, make all such dispositions of the properties moveable, or immovable forming part of the trust fund or any part thereof and enter into such agreements, assurances and things in relation there to as the trustees may deem proper for giving security for such loan and interest.

(i) INVESTMENT OF TRUST FUND

All money forming part of the trust fund and requiring investment shall be invested in any of the securities authorized by law for investment of trust funds which are permissible under Section 11(5) of the Income Tax Act, 1956 or shall at their discretion sell and/ or realize the same or any part thereof.

(j) IN WHOSE NAME MONEY TO BE INVESTED


All money forming part of the trust fund requiring investment shall be invested and the conveyance of assurance in respect of any immovable property/ properties forming part of the trust fund shall be obtained in the name/ names of trustees for time being of the board of trustees.

(k) OPENING BANK ACCOUNTS


The Board of trustees of **GYANODYA EDUCATIONAL TRUST**, may open any bank account or accounts with such scheduled bank which shall be operated jointly or severally by the parties as intimated to Bank.
